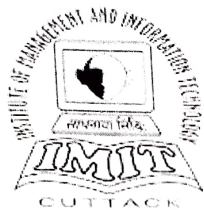

Accordingly, work order is hereby placed in favour of your organization for one year i.e. from 01-11-2023 to 31-10-2024.

You are requested to execute an agreement (in one non judicial stamp paper of Rs 10/-) with the Principal within 15.10.2023 which shall commence from the date of award of contract and shall continue for a period of one year. Further, you are requested to deposit a performance Security deposit of Rs 50,000/- provided in the form of Bank guarantee from any Nationalized Bank in favour of Principal, IMIT, Cuttack within 15 (Fifteen) days from the date of issue of this order. **You are also advised to carefully go through bellow term & conditions (second page of this work order) and inform the undersigned by above said date (i.e. 15.10.2023), that you have accepted this order, falling which this order will be treated as cancelled.**

P.T.O

Terms & Condition:-

1. You need to provide mess services as per the declared menus given in Annexure III of tender notice and the ingredients of foods should be good quality and branded.
2. The persons deployed by your Agency shall be required to provide their services at the designated place which will be assigned to them by Superintendent of concerned hostel's. No other persons other than the authorised persons issued with identity cards shall be allowed to enter the College/Hostel premises to run the canteen.
3. You are required to submit the name of staffs to be deployed, their Identity Proof and Qualification with proof to the Institute. An undertaking to the effect that no criminal record has been registered against the deployed person will also be produced by your organization. You are required to nominate a Co-ordinator or Supervisor who shall be responsible for immediate interaction with the authority, so that optimal services of the persons deployed could be availed without any disruption.
4. The actual Payment after deducting the establishment charge(room and other facility) i.e. Rs. 5000/- per month, electricity charge (as actual) per month and penalty amount(if any as per tender notice) shall be paid within 15 days of subssion of original invoices. Invoice should be separate copy, one addressing to Superintendent Boy's Hostel contining the actual charges incurred by Boy's hostel boarders and another addressing to Superintendent Ladies Hostel contining the actual charges incurred by Ladies hostel boarders. **Presently all the above charges will be deducted from the Boy's Hostel invoice amounts only.**
5. Proof of deposit of EPF, ESI and Service Tax (if any) has to be supplied by your organization to this office for record in every month.
6. Your organisation will provide uniform with name badges to all the canteen staffs at your own cost.
7. The persons deployed by your organization should have good police record and no criminal case pending against them.
8. In case of theft, indiscipline if observed, all the existing staff will be replaced immediately with replacement of another group.
9. The person to be deployed as Canteen staff should maintain discipline and behave properly inside the hostel campus.
10. Your staff will resposible for maintining the kitchen and dinning environment of both hostel Hygienic properly.
11. You are required to provide dedicated staffs for both hostels. Female staff for Ladies hostel is highly preferable.
12. No request or claim for price escalation shall be entertained during the tenure of the contract.
13. Extension for a period of another consecutive year is totally based on the satisfactory performance of agency and the decession of Hostel/College committee. But extensions period should not exceeds more than 2(two) consecutive years.
14. Any dispute with regard to this tender process will be subject to Hon'ble Court having Jurisdiction over Cuttack/ Hon' ble High Court of Odisha.
15. You are required to abide by all the other terms and conations provided in the tender call notice document. In case of breach of any terms and conditions attached to the agreement, the performance security deposit shall be forfeited.
